

2020 Delhi riots: Court frames charges of rioting, arson against 49 accused

NEW DELHI, JULY 25 /--/ A court here has framed charges under various penal offences, including rioting and arson, against 49 accused in a case of the 2020 northeast Delhi riots, setting the stage for their trial.

The court, however, discharged all accused of the charge of criminal conspiracy, saying, the element of prior agreement among the accused and others could not be inferred. It also discharged an accused of all charges, observing there was no concrete evidence about his presence in the riotous mob. Additional Sessions Judge Pulastya Pramachala was hearing a case against 51 accused. One of them named Suleman Siddiqui is yet to be arrested. According to the prosecution, the accused were part of a mob that trespassed, vandalised and torched a car showroom on the main Wazirabad road on February 24, 2020. "I find that a prima facie case is made out for offences punishable under IPC sections 147 (rioting), 148 (rioting, armed with a deadly weapon), 427 (punishment for com-

mitting mischief and thereby causing loss or damage to the amount of Rs 50 or upwards), 435 (mischief by



fire or explosive substance with intent to cause damage to the amount of Rs 100 or upwards) and 436 (mischief by fire or explosive substance with intent to destroy house, etc...." the judge said in an order passed on Monday. The judge said the accused will also face trial for the offences under IPC sections 450 (house trespass in order to commit any offence punishable with imprisonment for life), 188 (disobedience to order duly promulgated by public servant) and 149 (unlawful assembly).

"Since there is no concrete evidence of identification of accused Mohammed Aftab in the mob behind the incident probed in this case, therefore, he is discharged," he said. Underlining that the credibility of witnesses cannot be looked at during the stage of framing charges, ASJ Pramachala rejected the argument of the defence counsel that the prosecution had produced only "stock witnesses". A stock witness is an incompetent witness, providing unreliable testimony on directions of the prosecution. Regarding the claim of "inordinate delay" in registering an FIR on March 5, 2020, the court said the police were dealing with the scenario of riots along with the Covid-19 pandemic.

"There may be any other reason also for the delay in registering FIR, which can be explained at the time of trial. Therefore, the argument of the defence regarding a delay in the registration of FIR is not sufficient to discharge the accused persons," the court said. It said the plea of alibi taken by some accused, has to be proved and the same cannot be accepted at the present stage. The

court said as Call Detail Records (CDRs) were "supplemental evidence," they cannot be used as a ground for seeking discharge. "The surrounding and ancillary facts are required to be proved before CDR can be acted upon," it said. The court also dismissed the argument of the defence regarding the absence of a specific role assigned to each accused.

"The evidence on the record prima facie shows that accused persons were part of unlawful assembly, which was present at the spot and which came into action with a common object to go on a rampage, damage the properties and in pursuance to that common object, they set fire in the showroom," the court said. Noting the evidence before it, the judge said the crowd was initially being addressed by different speakers during the protest against CAA/NRC, and subsequently it became violent and engaged in rioting and arson. "From these circumstances, the element of prior agreement among the accused persons and others, cannot be inferred. Therefore, I do not find a case being made out for the existence of a criminal conspiracy," the judge said. An FIR was registered against the accused at Dayalpur police station. (PTI)

9 Indian fishermen arrested by Sri Lankan navy for alleged maritime boundary violation

RAMANATHAPURAM, JULY 25 /--/ The Sri Lankan Navy has arrested 9 Indian fishermen from Tamil Nadu for allegedly violating its maritime boundary, a state Fisheries department official here said on Tuesday. Two mechanised boats were also seized.

The fishermen, belonging to Mandapam in the district, set sail for fishing on Monday morning and were apprehended late last night between Katchatheevu and Neduntheevu, the official added. Meanwhile, the Tamil Nadu government said Chief Minister M K Stalin will attend a state conference of fishermen's associations here next month, that will discuss the issue of arrests and impounding of boats. Fisheries

minister Anitha R Radhakrishnan said that Stalin will participate in the meeting scheduled on August 18, based on an invitation from the fishermen representatives. An official release quoted him as saying that the CM has repeatedly taken up the fishermen issue with Prime Minister Narendra Modi and External Affairs Minister S Jaishankar through written communication as well as over the telephone. He recalled that Stalin had written last week to the Prime Minister, urging him to take up with the then visiting Sri Lankan President Ranil Wickremesinghe, protecting the traditional fishing rights of the Tamil Nadu fishermen. Pondicherry Varsity to implement NEP from this academic year: V-C Gurmeet Singh

PUDUCHERRY, JULY 25 /--/ Pondicherry University will implement National Education Policy (NEP) 2020 in all its departments and affiliated colleges from this academic year, its Vice-Chancellor Gurmeet Singh said here on Tuesday. Addressing media persons on

the university campus, he said the NEP has multi-dimensional features and 'education for empowerment' and 'skill development'. The Vice-Chancellor also asserted that the NEP does not impose any particular language as "everyone is assured of freedom to learn languages.

The NEP envisages holistic development to foster cognitive and physical skills of students. The policy promotes a multi-disciplinary approach that encourages students to explore various subjects and develop robust skill. Also, it emphasis on

integration of vocational education in general stream," he said. Singh said that the university has proposed to implement 'academic bank of credit' in all its colleges from the current academic year (2023-2024). It would permit students to leave the course midway and come back after some years to complete it. Citing financial crunch, the Vice-Chancellor said that the allocation of funds to the university for the current academic year was "not enough". The university needs more funds to carry out its proposals, he said. (PTI)

No infiltration into J&K till June-end in 2023: MoS Home Nityanand Rai



NEW DELHI, JULY 25 /--/ No terrorist could infiltrate into Jammu and Kashmir till June 30 this year while 14 terrorists entered the Union Territory in 2022, Union Minister of State for Home Nityanand Rai said in Lok Sabha on Tuesday.

Rai said the approach adopted by Government of India to tackle cross-border infiltration has ensured a perceptible decline in infiltration. There has been zero "net infiltration" into Jammu and Kashmir till June 30, 2023, 14 in 2022, 34 in 2021, 51 in 2020 and 141 in 2019, he said replying to a written question. The minister said the Government of India has adopted a well-coordinated and multi-pronged strategy to tackle cross-border infiltration, which includes tactical deployment of forces at the International Border (IB) and the Line of Control (LoC), use of technology like surveillance cameras, night vision cameras, heat sensing gadgets, etc., multi-tiered deployment along IB and LoC and border fencing. Deployment of intelligence personnel to collect advance and target-oriented inputs on infiltration, ambushes and foot-patrolling by the Army and the Border Security Force (BSF), establishment of Border Police Posts for generating local intelligence and taking pro-active action against infiltrators are among others, he said. Par panel suggests recipient consent so awards of cultural academies are not returned for political reasons

NEW DELHI, JULY 25 /--/ Emphasising that Sahitya Akademi or other cultural academies are "apolitical organisations", a parliamentary panel has suggested that whenever any award is given by them, the consent of the recipient must be taken so that he or she does not return it because of "political reasons".

The department-related Parliamentary Standing Committee on Transport, Tourism and Culture said this in a report tabled in both houses of Parliament on Monday. In the event that the awards are returned, the awardee "shall not be considered" for such an award in the future, the panel said in its observations. In its "Three Hundred Fifty First Report on 'Functioning of National Akademis and other Cultural Institutions', the panel underlined that return of such awards is "disgraceful to the country". "Such inappropriate incidents involving the return of awards undermine the achievements of the other awardees and also impact the overall prestige and reputation of the awards," the panel said. The committee observed that the awards given by each Akademi continue to be top honours for an artiste in India. "The Committee emphasises that Sahitya Akademi or other Akademis are apolitical organisations. There is no place for politics," according to a statement issued by the Rajya Sabha Secretariat on the report. "The Committee, therefore, suggests that whenever an award is given, the consent of the recipient must be taken, so that he/she does not

return it because of political reasons; as it is disgraceful to the country," it said. The committee recommended "prior concurrence of short-listed candidates for awards before finalisation", the statement said, quoting the report. "A system may be put in place where an undertaking is taken from the proposed awardee citing acceptance of the award and that the awardees cannot dishonour the award at any point of time in future. Awards may not be given without such an undertaking. In the event that the awards are returned, the awardee shall not be considered for such an award in the future," the panel said.

The committee noted the instances of recipients of awards, given by Akademis (such as Sahitya Akademi Awards), returning their awards in protest of certain political issues which are "outside the ambit of the cultural realms and the autonomous functioning of the concerned Akademi", the statement said. A member of the committee, however, "opined against the view" that artists, authors and other intellectuals and performers who have been recommended for awards must sign a commitment that they will not return the awards as a form of protest at any point in the future before they are able to receive it, it said. "He was of the view that India is a democratic country, and our Constitution has provided to every citizen the freedom of speech and expression and also the freedom to protest in any form. Returning of awards is only a form of protest," the statement said. The member

added that the committee must "strongly recommend to the Government to look into the actual issues in protest of which such awards have been returned and work towards resolving them. He was seconded by another Member," it added. The committee "questioned the re-engagement of such awardees who joined the Akademi after insulting it". Such inappropriate incidents involving the return of awards undermine the achievements of other awardees and also impact the overall prestige and reputation of the awards, the statement said.

"The Member again submitted that the Akademis and the other institutions should continue to work together with these artists and not shun them," it added, quoting the report. In February 2017, the Lok Sabha was informed that 39 writers had returned their Sahitya Akademi awards in the preceding three years claiming that the Akademi "kept silent" when their freedom of expression was "under attack". The then Union Culture Minister Mahesh Sharma had said in a written reply. There was a spurt in writers returning their awards to the Akademi in the backdrop of the institution's "silence" on the murder of fellow writer M M Kalburgi as well against the "communal" atmosphere in the country following the Dadri lynching incident of 2015. Shama in his reply had also said that the Akademi had convened a special Executive Board meeting on October 23, 2015 and December 12, 2015 in which resolution was passed requesting the writers to reconsider their decision. Newborn baby dies after wild cat drops him from roof in UP's Badaun

BADAUN, JULY 25 /--/ A newborn baby sleeping next to his mother died when he was picked up by a wild cat and dropped from the roof of their house here, police said on Tuesday.

The incident happened on Monday night in a village under Usawan Police Station area here, they said. The wild cat carried the infant, who was not more than 15 days old, in its mouth before dropping it when the father chased the cat, police said. According to police, the mother Asma gave birth to twins -- a girl child Alshifa and a boy Rihan -- fifteen days back in Gautra Patti

Bhauni village. Asma's husband Hasan told the police that ever since the twins were born, a cat was seen in the house everyday, but the alert family members used to chase it away. Hasan said that sometime on Monday night, the cat carried away Rihan, asleep close to Asma. As Asma got up and raised an alarm and screamed, Hasan ran after the cat which dropped the child and he fell from the roof and died on the spot, police said. SHO Usawan Ramendra Singh confirmed the death of the infant. He said the family members of the baby have not given any complaint letter in the matter yet. (PTI)
